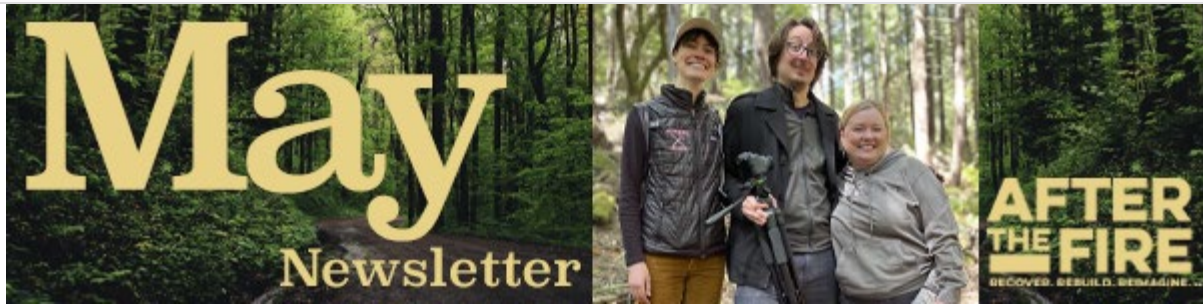

New ATF Advisory Board

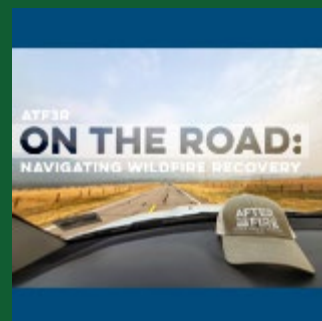
